Special Conditions:

- If you are successful in your application for this position you can only commence employment if you have a current Paid Working with Children Blue Card or your Blue Card is in the process of being renewed (paid for by Meridan State College).
- Commencement in this position is dependent on you passing a health assessment by a Government Medical Officer or oth duly qualified medical practitioner (paid for by Meridan State College).
- This position is employed by Meridan State College.
- The Crossing Supervisor will supervise the school crossing located in the Sunshine Coast Council car park adjacent to Meridan State College primary school.
- You will be required to work on a rostered one week on/one week off basis and be available for relief opportunities on your rostered days off.
- School Crossing Supervisors will be trained, authorised and inducted by the Department of Transport and Main Roads.
- School Crossing Supervisors will be supplied with standard personal protective equipment (PPE), in accordance with the Workplace Health and Safety Act 1995 (WH&S) and various Australian Standards.
- Applications will remain current for 12 months

Under Section 122F of the Transport Operations (Road Use Management) Act 1995 an applicant for, or a person occupying a School Crossing Supervisor position must give written notice

- (a) for a charge laid or an offence of which the applicant is convicted before the application is made with the application; or
- (b) for a charge laid or an offence of which the applicant is convicted after the application is made but before the application is decided – as soon as practicable after the charge is laid or applicant is convicted; or
- (c) for a charge laid or an offence of which the crossing supervisor is convicted after becoming a crossing supervisor as soon as practicable after the charge is laid or the crossing supervisor is convicted.
 - The minimum age for employment as a School Crossing Supervisor is 18 years of age.
