## Dear Parent/Carer



In the first semester this year, your son has been involved in the Pursuit Program.

As a culmination activity and to celebrate the completion of the program, your child has the opportunity to participate in an afternoon of Go Kart racing at the **Big Kart Track**.

As this is an expensive activity we are asking that each student contribute \$50.00 towards the activity. This is less than half the cost of what the activity would normally cost when you consider Go Kart hire and the cost of the bus to get there.

Activity: Go Kart Racing

Venue: The Big Kart Track, Landsborough

When: Tuesday 21 June 2016

Cost: \$50.00 (Due date Wednesday 15 June 2016)

We would like to see your son take some responsibility towards the cost by doing extra chores around the home, contributing some of their own pocket money or asking family and friends if they can do some paid jobs for them such as washing cars, mowing lawns or gardening.

Attached is a parental permission form and a driver's indemnity form from the Big Kart Track.

In order for us to finalise numbers please fill in the permission forms attached and return with payment to Client Services by **Wednesday 15 June 2016**.

This is the final activity in the program and aims to encourage students to engage in school through:

- Involvement in group activities.
- Overcoming fears by facing challenges.
- Valuing the diversity of people.
- Physical security.
- Self-determination and control over one's life.
- Leadership and decision making.
- Cooperative teamwork.
- Goal setting and achievement.
- Resilience development.

## Activity details:

- The driver must be 152cm tall and a minimum of 12 years of age to drive Big Track.
- Students will travel by bus to the Big Kart Track at Landsborough. They will then be briefed in the safety and operation of the carts by trained personnel from Big Kart Track. Helmets and hair nets will be supplied.
- The risk level of the activity is classified as <u>high</u>, in that there are hot engines involved and that the participants will be in control of their own go-cart on an outdoor track with other go-carts controlled by students and the public.
- Students will be driving several laps of the track and will gain confidence as they progress through the circuit.
- Teachers attending the activity will be Stuart Thorpe and Nigel Riseley.

- Potential hazards include but are not restricted to the following:
  - 1. Burns (if the engine is touched.)
  - 2. Scrapes or grazes if a driver crashes the cart through inappropriate behaviour or reckless driving of others.
  - 3. Serious Injury by not following the rules of Big Kart Track.
- Students <u>must</u> wear strong, enclosed shoes in good condition, with their sports uniform.
- Students must also bring sunscreen, water bottle, hat and sunglasses.

Any student who has not paid their Student Resource Scheme fees (including subject fees where applicable) or who does not have a current payment plan in place will not be able to attend the excursion. Those students who do not attend will be provided with alternate learning/assessment activities.

Payment for excursions will not be accepted after the specified due date.

Refund policy: Please note some excursion payments are non-refundable due to the nature of prepayment of the event. If a parent/carer wishes to apply for a refund due to non-participation, please complete a 'Request for Refund' Form from Client Services.

Any relevant changes to medical details or emergency contacts that are currently kept on record by the college should be updated immediately. This includes information on any recent medical conditions that may limit, or be aggravated by your student's participation in this activity. And also includes details on any medication currently being taken that might be relevant in a medical emergency.

Please be aware that when involved in activities there is an inherent risk of physical injuries occurring without any negligence on the part of the school and in such circumstances the responsibility for the injury and any associated costs will rest with you and not the school. Parents are advised that the Department of Education, Training and Employment (DETE) does not have Personal Accident Insurance cover for students. DETE has public liability cover for all approved school activities and provides compensation for students injured at school only when the Department is negligent. If this is not the case, then all costs associated with the injury are the responsibility of the parent or carer.

It is a personal decision for parents as to the type and level of private insurance they arrange to cover students for any accidental injury that may occur.
